



Los Angeles City Permitting System (LACPS) Update

LACPS is a cloud-based platform that will replace LADBS' aging permitting, inspection, and code enforcement systems. It's designed to give residents, contractors, and businesses easier access to critical services all in one place.

In March 2026, we will be launching the first phase of LACPS starting with Express Permits and a redesigned customer portal.

Introducing the New LADBS Invoice Tracking System (IVTS)

LADBS has launched the Invoice Tracking System (IVTS) to make invoice submission, tracking, and processing easier for staff and customers.

The system streamlines the entire process, from invoice submission to payment, while giving staff the tools they need to update statuses and manage vendor information in real time.

During or after registration, select any/all North American Industry Classification System (NAICS) codes that apply to your business. Once registered, RAMP automatically emails notifications when bid opportunities are posted that match your chosen NAICS codes.

The Regional Alliance Marketplace for Procurement (RAMP) website will undergo enhancements and will be shutdown from December 9, 2024 to January 7, 2025. During this time, all contract opportunities will be suspended until the first quarter of 2025. Vendors will not be able to view solicitations on RAMP, complete their Business Inclusion Program (BIP) outreach, submit BIP Summary Sheets, or submit certification applications.
