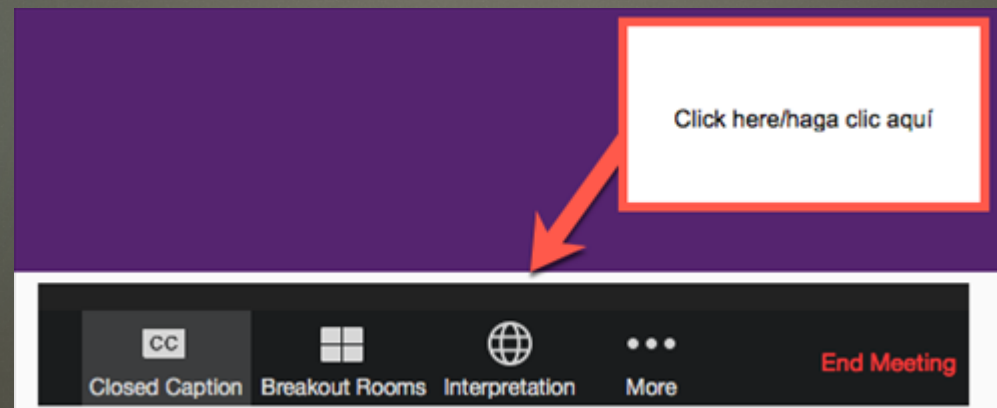

# Local Enforcement Agency (LEA)



- ▶ State-mandated regulatory program that permits, inspects, and enforces State and specific local standards for solid waste facilities, including landfills, transfer stations and various other types of recycling facilities.
- ▶ The LEA enforces solid waste regulations found in Title 14 & Title 27 of the California Code of Regulation (CCR) and Chapter XIX of the Los Angeles Municipal Code (LAMC).
- ▶ The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle).

# Purpose of Informational Meeting



- ▶ Public Informational Meeting is part of the permitting process to issue a new or revised SWFP as required by California Code of Regulations, Title 27, Section 21660.2
- ▶ Provide the public with information pertaining to the project and permitting process for new or revised permits
- ▶ Allow the public to provide feedback and/or comments on the project related to the solid waste facility permit



# SWFP Permitting Process - LEA

- Facility Operator Submits SWFP Application
- LEA has 30 days to determine if it is complete and correct
- LEA has 30 days to hold public information meeting
- LEA has 30 days to draft proposed permit
- LEA submits proposed permit to CalRecycle
- CalRecycle has 60 days to concur or object to proposed permit
  - Prepare Board Report
  - Conduct State inspection
  - CalRecycle Public Meeting

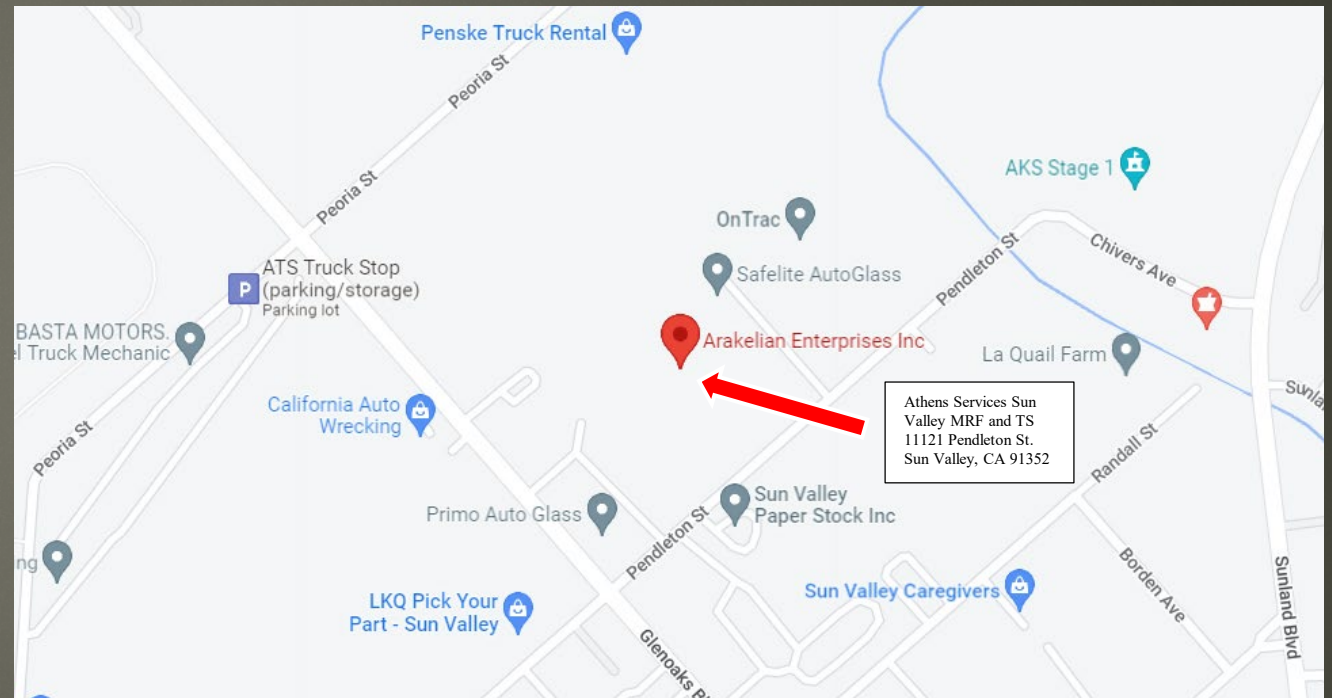

# Project Description



Athens Services Sun Valley MRF and TS is permitted to accept 1,500 tons of municipal solid waste per day and to accept waste from 7:00AM to 8:00PM, 7 days a week, and 24-hour processing.

Athens Services submitted an application package to revise the SWFP to change operational time to accept and transfer waste from 7:00AM to 8:00PM to **5:00AM** to 8:00PM.

# Overview of Facility Operations



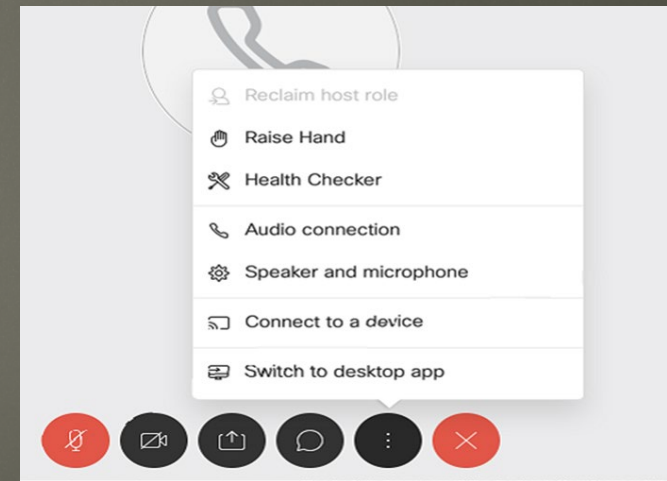
